ORDER

Whereas disciplinary proceedings were initiated against you, Mr. Farman Ali, Assistant (BPS-16) of the Punjab Judicial Academy on the charges of misconduct, by appointing Mr. Tariq Iftikhar D&SJ (R)/Director Trainings PJA, as inquiry officer vide order dated: 3rd Dec. 2020.

And whereas the Inquiry Officer submitted inquiry report on 24^{th} Dec. 2020 and recommended penalty i.e dismissal from service u/s 4(b)(vi) of PEEDA Act 2006 against you.

And whereas on receipt of inquiry report, Show Cause Notice cum Notice for personal hearing was served upon you by appointing Mr. Muhammad Siddique D&SJ (R)/Director Academics PJA and you were summoned for personal hearing on 17th February 2021 at 10:30 a.m, which was availed by you.

And whereas patience hearing at length was given to you during the course of personal hearing. But you failed to produce any tangible evidence to prove yourself innocent. The Hearing Officer did not find any substance in the written additional defense filed by you/accused. He agreed with the penalty imposed by the Inquiry Officer that Accused Official was found committing gross misconduct in terms of section 2(n) of the act ibid and also committing harassment to female colleague at workplace.

Now therefore, Hon'ble Chief Justice Lahore High Court/Chairperson PJA, as Competent Authority in exercise of the powers conferred under section 4(b)(vi) of the Punjab Employees Efficiency Discipline and Accountability Act 2006 and under section 8(1)(f) of the Punjab Judicial Academy Act, 2007 delegated to him by the BoM, its 5th Meeting held on 28th September 2010, by perusing the relevant record and considering the recommendations made by the inquiry officer & hearing officer, do hereby decide the case as under:

1- Name of the Official:

Mr.Farman Ali (Assistant) (BPS-16)

2- Penalty Imposed:

Dismissal from service.
