on 19th March, 2020. He was the 50th Chief Justice of Lahore High


Court, Lahore who served from 19^{th} March 2020 till 05^{th} of July 2021.

CHAPTER-1

INTRODUCTION

Establishment of the Academy:

The Punjab Judicial Academy Act was passed by the Punjab Assembly on 5th of October, 2007 and assented to by the Governor of Punjab on 29th of October, 2007. The Punjab Judicial Academy Act, 2007 was promulgated on 30th of October 2007. Punjab Judicial Academy was established under the Punjab Judicial Academy Act, 2007 and it was housed in a building of the Lahore High Court at Fane Road Lahore in the year 2009.

In the Annual Development Program (ADP) 2009-2010 of the Planning & Development Department, Government of Punjab, a piece of land measuring 393 Kanal 7 Marla was acquired at the cost of Rs.93.921 million. After taking possession of the same, new campus of PJA is under construction at Kala Shah Kaku. The administrative block, male hostel, female hostel, residences of employees (Grade 1-10) are near completion whereas the remaining is likely to be completed by the end of next year.

The Punjab Judicial Academy imparts training to the judicial officers and court personnel with a view to develop their capacity, professional competency and ethical standards for efficient dispensation of justice and matters ancillary thereto.

Vision & Mission:

The Punjab Judicial Academy's vision is to become a Center of Excellence for Judicial Education so as to enhance capacity, competency and professional efficiency of Judicial Officers and Court Staff.

The mission of the Academy is to bring in conformity the level of knowledge, skills and attitude of the Judicial Officers discharging their functions in the province of Punjab with legal instruments,

modern technology/E-learning and strictly following the verdicts pronounced by the Superior Courts of the Country. Academy impart legal knowledge and information through face-to-face trainings, Online/Webinar trainings, conferences, symposia, Lectures, workshops, and research work. Academy circulate knowledge & skill by publication of handbooks, bench books, articles, judicial law journal, criminal & civil citators etc. The Academy provides a pedestal to all the stakeholders of the justice system to improve their skills and it aims to ensure their consistent growth of legal knowledge and development. Academy sensitized the stakeholders of justice system about all sorts of biases and discrimination.

Functions of the Academy:

Functions of the Academy are fully elaborated Section-4 of the Punjab Judicial Academy Act 2007. The Act ibid emphasizes the use of modern techniques for imparting judicial training and maintaining international standards for evaluation & teaching methods. Academy holds quality examination and evaluation for the training imparted to the judges. Functions of Academy are highlighted as under: -

a) Impart pre-service and in-service training to the judicial officers and court personnel;

- b) Develop the skills and techniques for court management, case management, delay reduction, alternate dispute resolution and judgment writing;
- c) Conduct examinations and award certificates and diplomas;
- d) Develop training courses relating to administration of justice including use of information technology;
- e) Hold conferences, seminars, lectures, workshops and symposia relating to court management, administration of justice, law and development and legislative drafting;
- f) Publish books, journals, research papers and reports on important topics relating to administration of justice;
- g) Promote research on case management, court management, trial skills and judicial reasoning;
- h) Encourage legal and constitutional research;
- i) Inculcate and promote ethical values and standards in judicial officers and court personnel;
- j) Coordinate with other educational and training institutions including the Federal Judicial Academy;
- k) Conduct training and examinations of other officers and personnel on the direction of the Board;
- l) Perform such other functions as may be assigned to it by the Board.

The needs of the time have necessitated promulgation, amendments of various new laws, legal concepts, new theories, the expertise of which is scarce in the Bench and the Bar. The Academy undertakes to impart such knowledge and training to all the stake-holders of the judicial system through experts, scholars, members of the superior judiciary, renowned lawyers, medical experts, senior police officers, reputed scholars, motivational speakers and professors of different institutions.

Section 5 of the Punjab Judicial Academy Act,2007 lays down that Academy shall use all the modern techniques to impart trainings. Distance learning through webinars and skype sessions is also being considered for training of judges and court personnel in order to provide them firsthand knowledge of core & non-core issues at door step.



The participants are provided opportunities to visit Punjab Forensic Science Agency and Punjab Safe City Authority to apprise them of the modern techniques of investigation and the assistance that these institutions can provide in resolution of the matters brought before courts. The aims to prepare all the stakeholders of the justice system for providing even-handed, speedy and inexpensive justice without fear and favour to all the segments of society.

The Academy conducts research and training program to improve the skills and knowledge of Judges for implementation of new laws related to electronic/cyber-crimes, money laundering, environmental laws, intellectual property laws, consumer protection law, gender sensitization and human rights etc.

Academy's objective is to provide continuing judicial education based on research to enhance competency and professionalism of key players of justice sector.



CHAPTER-2

MANAGEMENT OF P.JA

The Management and Administration of the Punjab Judicial Academy vests in the Board of Mangement (BoM), headed by the Hon'ble Chief Justice of Lahore High Court as Chairperson. The Board of Management comprises of the following members: -

Section 8 of the Punjab Judicial Academy Act, 2007 prescibes functions of the Board of Management. The Board exercise supervisory and administrative control over all affairs of the Academy. The Board lays down the policy and program for training and approve courses of the Academy; evaluate or cause to be evaluated the performance of the Academy; approve the annual budget and revised budget estimates of the Academy; cause proper books of accounts to



be maintained for all sums of money received and expenditures incurred by the Academy and arrange for the audit of accounts; determine the terms and conditions of service of the Director General and staff of the Academy; create, abolish or upgrade a post; appoint an officer in BS-16 or above; and prescribe qualifications, conditions of service and other matters relating to faculty, officers and staff.

The Board may also purchase, acquire, hire, dispose of or construct any property for the Academy; hold, control and administer the property of the Academy; receive grants-in-aid and donations from the Federal Government, the Government or any other organization, person or agency; regulate, determine and administer all matters concerning the Academy; appoint advisors, consultants and experts for assistance; appoint or hire permanent or visiting faculty; assign a specific power to a person or organization and exercise any other power ancillary to the aims and objects of the Academy.

In this regard., Punjab Judicial Academy has also signed MOUs with The Asia Foundation, Punjab Information Technology Board (PITB), Sindh Judicial Academy and Khyber Pakhtunkhwa Judicial Academy. The objective of collaboration is capacity building of judges through specialised training in different fields of law and exchange of information qua techniques and ways to impart legal education to different stakeholders of justice sector.

The Punjab Judicial Academy is committed to conduct a wide range of Research and Development Program on the improvement and implementation of laws, with collaboration of foreign Institutions and their renowned experts in the fields newly developed laws.

During this year, PJA has conducted various training programs/workshops in collaboration with following institutions:

- (i) Six Days Capacity Building Training Workshop for designated Judges of Commercial & Overseas Courts in collaboration with the **World Bank Group** and **Planning & Development Board**, Government of the Punjab w.e.f. 7th to 12th September, 2020.
- (ii) To equip the commercial courts' judges with relevant laws and precedents, PJA has organized a four days Training Workshop in collaboration with the **Planning & Development Board**, Government of the Punjab w.e.f. 7th to 10th June, 2021.

CHAPTER-3

ACADEMIC ACTIVITIES

Academic Wing of PJA conducts different programs for judicial training of the judges and court personnel. Judicial Training at PJA has been primarily of two types:

- 1. Pre-service Training
- 2. In-service Training

The first pre-service training program for 18 newly appointed Additional District and Sessions Judges was conducted by the PJA with effect from 5.10.2009 to 26.12.2009. The most of the topics covered were of substantive and procedural laws, civil as well as criminal, court administration, case management, judicial code of conduct and ethics, and some personal well-being grooming sessions were also conducted. Visits were also arranged to the Police Training Institute and Sessions Court.

In-service training program includes different training courses including GTP. General Training Program (GTP) was firstly initiated in the year 2015. However, a Judicial Training Needs Assessment was conducted by European Union Punjab Access to Justice Project (EU-PA2J) with the approval of Hon'ble Chairperson Board of Management PJA in 2015. However, in May 2016, a thorough assessment of institutional capacity of PJA was conducted by inviting Dr. Livingston Armytage, Director, Centre for Judicial Studies, Australia with support from EU-PA2JP. Thereafter, a month long intensive Training of Trainers program was conducted at the PJA in August, 2016. In July-September 2016, the Academy chalked out a roadmap for its future activities. All the efforts were aimed to enable the PJA to bring a positive change in the judicial system in Punjab. Since then PJA conducts the following pre-service and in-service trainings: -

PJA Academic wing designs the curriculum for these trainings relating to core and non-core issues including Administration of Justice, use of Information Technology, Research Techniques, Mock Trials and also develop the skills for Court and Case Management, Delay Reduction, Alternate Dispute Resolution and Judgment Writing etc.

The Academic wing prepares the reading material for the participants of different training programs which is uploaded on PJA website. This wing also prepares the assessment tests and MCQs etc. for evaluation of the trainee judges and court staff.

The Academic wing conducts pre & post training tests of the participants to determine their capacity at the start of training and improvement made after receiving the training. Academic Wing encourages the academic activities in the Punjab Judicial Academy by conducting seminars, workshops, national and international conferences and panel discussions.

1. Detailed Training Programs

General Training Program (GTP) is the signature program of the Punjab Judicial Academy. Since 2015, GTP was launched with the objective to ensure training of every judge of district judiciary, once a year. - 2. To enhance skills of conducting trials.
- 3. To sharpen the judgment writing skills.

- 5. To inculcate healthy life style in judges






(ii) Cyber Law Report


