- 4) Under Rule 38(2) (a) single stage-two envelopes bidding procedure shall be adopted. Bids should be dropped in the tender box kept in the office, on or before the closing date mentioned above in table. No bid shall be accepted after due date and time.
- 5) 5% of total estimated values as bid security in the shape of CDR/PO, duly pledged in favour of **Judicial Training Fund**, must be submitted along with the Technical bid. Bid without security shall not be accepted.
- 6) Technical proposals shall be opened on the same day at as per schedule given above in the presence of the bidders or their authorized representatives, who choose to be present, in the office of the undersigned.
- 7) Bids not fulfilling minimum requirements as stipulated in the bidding documents shall be declared non responsive. Financial Proposals of such non-responsive/ disqualified bidders shall be returned un-opened.
- 8) Incomplete, conditional and bids without appropriate bid security shall not be considered.
