

## TENDER NOTICE FOR THE PRINTING OF ANNUAL AUDIT & PERFORMANCE REPORTS

Electronic bids are invited on e-Procurement System {(e-Pak Acquisition Disposal System (EPADS)} at <a href="https://www.punjab.eprocure.gov.pk">www.punjab.eprocure.gov.pk</a> from the Bidders i.e. general order suppliers/manufacturers/firms engaged in trading, registered with relevant Authorities/Tax Departments (Income Tax, Sales Tax), having professional tax certificate for the FY-2024-25 from Excise & Taxation Department and registered on e-Procurement System (EPADS). The Bids should be submitted as per rule 38 (2) (a) PPR-2014 single stage two envelope procedures.

2. All electronic Bids must be accompanied by a scanned Bid Security of 2% of the estimated price in the name of "Judicial Training Fund", PJA in the form of CDR/Bank Guarantee / Demand Draft / Pay Order. The original instrument of bid security must be delivered in PJA office prior to closing date of submission of bid. Late Bids shall be rejected. - 4. Bidding Documents are immediately available after date of publication. Punjab Judicial Academy (PJA) will not be responsible for any cost or expense incurred by Bidders in connection with the preparation or online submission of Bids. In case of official holiday on the day of submission, next day will be treated as closing date. The Bidding document carrying all details can also be downloaded from the website of Punjab Judicial Academy,www.punjab.eprocure.gov.pkandhttps://eproc.punjab.gov.pk/ActiveTenders.aspx
- 5. All prospective bidders shall be required to quote rate of each/every item in the package/lot. Any item mentioned without quoting rate shall make the bid non-responsive. The lowest evaluated bidder shall be determined on the cumulative quoted rate of the entire lot/package. The bids shall be submitted under "Single Stage Two Envelopes Bidding Procedure" as contained in Rule 38(2)(a) of the Punjab Procurement Rules, 2014. All the rates should be inclusive of GST/PST and valid till 30.06.2025.
- 6. The bid security will be refunded after finalization of the tender. However, the successful bidder shall deposit an amount equivalent to 10% of the total value of the contract as Performance Guarantee in shape of CDR/Bank Guarantee /Pay Order which shall be refunded on successful completion of the contract obligations. The delivery time of items would be as per the deadline specified in the purchase order.
- 7. As per rule 35 of PPRA-2014, the procuring agency reserves the right to accept or reject all bids or proposal at any time prior to the acceptance of a bid or proposal.
