Electronic bids are invited on e-Procurement System {(e-Pak Acquisition Disposal System (EPADS))} at www.punjab.eprocure.gov.pk from the Bidders i.e. general order suppliers/manufacturers/firms engaged in trading, registered with relevant Authorities/Tax Departments (Income Tax, Sales Tax), having professional tax certificate for the FY-2024-25 from Excise & Taxation Department and registered on e-Procurement System (EPADS). The Bids should be submitted as per rule 38 (2) (a) PPR-2014 single stage two envelope procedures.

All electronic Bids must be accompanied by a scanned Bid Security of **2%** of the estimated price in the name of “**Judicial Training Fund**”, PJA in the form of CDR/Bank Guarantee / Demand Draft / Pay Order. The original instrument of bid security must be delivered in PJA office prior to closing date of submission of bid. Late Bids shall be rejected. The relevant branch of bank (from where the bid security is being issued for bidder) should also send scanned copy at the following email address: admin@pja.gov.pk

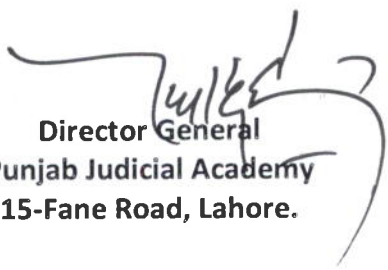
3. The complete electronic Bids must be submitted online at www.punjab.eprocure.gov.pk, as per the following schedule:
